

Innovations in Registration Workshop

This workshop covered computer and Internet security, using Internet payment options for club registrations. Most of the allotted time was spent describing how the proposed (now accepted) background screening process will work in the SWIMS registration database. To begin with, only coaches will be screened, as they felt the coaches had the closest contact with athletes. It will cost \$20 for each coach, and will screen for any plea of guilty or no contest at any time, past or present, or the existence of any pending charges for any felony, any offense involving use, possession, distribution or intent to distribute illegal drugs or substances, or any crime involving sexual misconduct. A pilot program involving 5 LSCs has been conducted.

Registration/Membership Committee Business meeting

The committee went over ongoing SWIMS enhancements and legislation that affects membership. The LSCs that participated in testing the background screening processes in SWIMS gave a report to the committee. There is concern for athlete privacy and the USA Swimming Mailing Service. (All committees are in a 'lame duck' situation, since new committees will be appointed shortly)

Facility Development

USA Swimming created a Facilities Development Department to assist in developing and planning new aquatic facilities, as well as renovating and upgrading existing facilities. The nationally known and respected staff includes Mick Nelson, Club Facilities Director, John McIlhargy, Director of Aquatic Industry Relations, and Sue Nelson, Aquatic Programming Specialist. They offer a full gamut of information, suggestions, and guidance, and described success models – from small pools to big pools. Their "motto" – Program it – Design it – Build it – Operate it.
